Dear Ms. Salas:

We are hereby submitting this second amended Transmittal No. 82 for Bay Springs Telephone Company (effective January 1, 2002) in order to correct an error in the Description and Justification submitted with that transmittal. The Description and Justification should have stated that effective January 1, 2002 the residential and single line business End User Common Line Charge is increasing from \$3.50 to \$5.00 per month. The Description and Justification was filed on a confidential basis, however, the EUCL rate is not confidential, and therefore this Second Amended Transmittal is being filed on a non-confidential basis to correct the error. The information presented in the Description and Justification regarding the impact of the increase in the EUCL rates on revenues was properly based on an increase in the residential line / single-line business line EUCL rate from \$3.50 to \$5.00 per month, and therefore is not changed.


