The accompanying tariff material issued by John Staurulakis, Inc. ("JSI"), and bearing Tariff F.C.C. No. 1, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

The filing, to become effective December 3, 2004, consists of tariff pages as indicated on the following checksheet:

In this filing, JSI proposes modification of JSI Tariff FCC No. 1 to introduce a Data-Only Option for Asymmetrical Digital Subscriber Line ("ADSL") Service for Pineland Telephone Cooperative, Inc. ("Pineland"), an issuing carrier for JSI Tariff FCC No. 1. Regulations already exist in Section 16.2 for provision of ADSL on a Data-Only basis. Pineland currently provides ADSL under the Voice-Data Option and will continue to do so at the existing Voice-Data Option rate.

In this filing JSI also proposes two revisions to the Pineland ADSL rate page to conform the rate page to the corresponding ADSL regulations in Section 16.2. These revisions do not have any impact on the provision of service or rates for either existing or future customers. The first of these revisions serves to eliminate the distinction between residence and business arrangements. Currently, Pineland's ADSL rate page in the tariff indicates separate rate elements for "Residence Arrangements" and "Business Arrangements" although listing the same rate for both "classes." The regulations in the tariff do not provide for such classes of service. The second of these revisions serves to
