With this filing, SWBT proposes to introduce SBC Federal Access Solution Transport Program (FAST) into Section 10, of F.C.C. No. 73. The SBC FAST Program will allow each of the Federal Government's authorized contractors providing network services under contract to obtain discounted rates for Specified services. The FAST Program will only be offered to the Federal Government or agents of the Federal Government. In addition, SWBT will limit the Federal Government Telecommunications Service for new customers as of November 25, 2004. No changes will be made to existing customers.
