Northrop and the undersigned, counsel for Columbia Millimeter Communications, L.P. and for Astrolink Communications, Inc., met with D'wana Terry, Chief of the Public Safety and Private Wireless Division of the Wireless Telecommunications Bureau, to discuss the above-referenced proceeding involving microwave services in the 38.6 - 40.0 GHz frequency band.
