Dear secretary and commissioners of the FCC,

Included with this letter is almost 1000 signatures (probably more than that by the time you read this) of those who have signed a petition that reads thus:

Save environmental news on public radio:

WCVE 88.9 FM "public radio" moved their weekly 30 min environmental news show, *Living On Earth (LOE)* to Saturday 4:30p

when most environmentalists are OUT ... IN the environment!!

We the undersigned Petition WCVE to move *LOE* to 6:30p

1 day workweek (M-Th) following *Marketplace*:

Diversity is *sorely* lacking in Central Virginia, and is getting worse! When I drove a taxicab, people actually paid higher tips because I was able to bring in Norfolk 96.1 and 89.5 for some blessed relief.

When my car was broken into with money on the floor between the seats, some several dollars worth of toll change, quarters and dimes, the thief left that and took the cassette tapes!! That is how bad radio is in Central Virginia!

WRVA used to have a bit of something for everyone as "family radio". WLEE used to have Pat Buchanan, who is as conservative as the rest of the radio ... BUT Buchanan made it a POINT to have guests from the other end of the political spectrum for a really respectful conversation! Doug Wilder (first black Governor since Reconstruction) did a "phone-ringing-off-the-hook" show for WRVA for some time. Larry King used to do a talk show that did a "softball", but at least present, job of covering a fair diversity of human experience, ideology and culture. All these are gone, replaced with R+B, Oldies and Rock that we've heard 100 times if once. The talk is ALL conservative or buffoonery or both. All balance is gone.

And yet there was hope, to paraphrase "public" TV, that "if public radio doesn't do it, who will?"

Not "public" radio here in Richmond!! National criticism of "public" broadcasting had some wags referring to PBS as the "Petroleum Broadcasting System" due to the preponderance of support from Mobile Oil and crowd for unchallenging regurgitations of culture we learned about dozens if not even hundreds of years ago!

It turns out to be even worse here in Richmond than for the nation.

The programming reflects a culture of "don't rock the boat" as they "pour oil on the waters" of discontent. Even classical music enthusiasts complain that "public" radio WCVE 88.9FM airs a selection of "high-brow-muzak" to "soothe the savage beast" into somnolence. Radio as tranquilizer. This is a world more and more dominated by the 2% of the population that controls 42% of the country's assets. We get more stock market reports that even wealthy people don't listen to. It is all hype. My wealthy ancestors and my wealthy acquaintances all tell me the way to invest is to carefully research a company, buy the stocks and *sit* on them. Who cares if they go up or down a few points. Furthermore, if they are serious, they look up their stocks in print. It is rare that even investors make a decision based on the stock readings on the radio. Furthermore, less than half of us own stocks anyway! So why is there no *labor* report? Because "public" radio is a sham in Richmond Virginia.

Example: When the three blocks of beautifully preserved 19th century working-class (and still affordable) rowhouses in the Oregon Hill historic district were destroyed by Ethyl Corporation, many wondered why that controversy was not the subject of a local talk show on "public" radio WCVE 88.9 FM.

Most public radio stations such as WHRV 89.5 FM out of Norfolk DO have local talk shows that make it a *point* to discuss controversial community events and the local flavor of national trends. None here. *loc'd OJ9*

Here in Richmond Virginia it *really IS* the "Petroleum Broadcasting System"! It turns out that the man serving Ethyl Corporation's CEOs and stockholders, A. Prescott Rowe was at that time simultaneously the Chairman of the Board of Directors of public radio/TV!! Even worse, his *paid* position at Ethyl was "VP of External Affairs" wherein he manipulates the image of Ethyl before the City Council, the General Assembly and in the Media ... he is Ethyl's PR man *AND* the director of the directors of tax-supported monopoly radio!!

No media covered the impact of demolition of "substandard" houses on the tax base. Every \$80,000 house that is sent to the landfill and converted into a \$9,000 empty parcel of land steals from the rest of us who must then pay higher taxes to cover the same or even greater municipal expenses. Every abused and then demolished house blows a hole in our tax base that pays for our health, welfare and safety! Why wasn't this issue on the air?

A. Prescott Rowe is paid as the PR man for Ethyl to manipulate the media to create an atmosphere conducive to greater profit for the CEOs and stockholders of Ethyl Corporation. Then this same servant of Ethyl stockholders directs the directors of tax-supported and monopoly "public" radio for all of Central Virginia.

It is no small wonder that the hour of classical music is the hour of conversation that did not happen. This is especially galling considering that classical music enjoys THE wealthiest audience of ANY musical category!! Why are the peasant's tax dollars paying for the elite's music especially when the very same elite are stomping our historic and affordable housing?

Motivation and interest-group politics also explain why asking WCVE to be a culturally and ideologically diverse and eclectic station is just like asking Ethyl Corporation to become an enthusiastic advocate of electric busses and trains! Ethyl manufactures fuel additives (the "octane" in gasoline) that make gasoline a reasonable fuel for modern engines the world over! Environmental and urban (automobile-optional living) programming is NOT to Ethyl's advantage ... and so does not get prime time (and often NO) billing.

Rather than dragging WCVE 88.9FM kicking and screaming into a vision of radio that does not fire their soul ... many feel it is better to flesh out the representation of human experience, culture, ideas and *sources* with a second *community* radio station. **Community** radio means that *you* do a show. *Community* radio means that *you* are the pied piper, not major corporations. *Community* radio means that *you SAY* what is important, not wonder when the commentator on TV or radio is going to ask your question, float your idea for consideration. YOU set the agenda in *community* radio. YOU are the *source* of the culture, the ideas, the solutions. You *matter*.

To create more REAL competition that retains the LOCAL aspect of good radio ... we need more radio stations owned by more LOCAL people and especially community public service organizations.

Community service organizations can create programming to serve communities-of-interest that commercial, religious and "public" stations will not serve. Most importantly, community organizations have the *will* to serve currently unserved groups. Where there is a will, there is a way, no will, no way.

Please give us the means to exercise our right of assembly and freedom of speech in a manner that is substantive. Allow us a chance at the airwaves that the public owns as the public commons. Allow us at least ONE channel for Democracy to bloom! Allow us to have at least ONE channel where we can create a ground safe and fertile for conversation and culture exchange instead of using the might of the US government to merely make the world safe for commerce at the expense of culture exchange and conversation!

Please approve RM-9242 with no changes.
