

On March 31, 1999, the undersigned submitted the enclosed letter to Chairman Kennard with copies to the listed individuals regarding the referenced Docket No. 98-172.

The letter describes the formation of a group which met initially to discuss issues raised in the Commission's Notice of Proposed Rulemaking, the progress which was made developing an alternative band segmentation plan and that ultimately the group was unable to reach a consensus prior to the deadline for filing comments. 
As you are aware, the 18 GHz Joint Working Group (“JWG”), whose members include several companies representing both satellite and terrestrial fixed service interests, came together to discuss issues raised in the Commission’s Notice of Proposed Rulemaking (“NPRM”). This group met initially under the joint sponsorship of the National Spectrum Managers Association (NSMA) and TIA, then subsequently as an independent ad hoc group. The co-conveners of the JWG were Mr. Bill Lye and Mr. Phil Salas. At its last session, the JWG made considerable progress toward developing an alternative band segmentation plan that could be submitted to the Commission to resolve the troublesome defects in the proposal advanced in the rule making. However, the JWG was not able to achieve unanimity for this alternative band plan prior to the deadline for filing comments, and the JWG has not met since to further discuss an appropriate 18 GHz band plan.

We ask that you urge the JWG to reconvene, to include all interested parties and to push hard toward a recommendation for resolving the issues presented by the NPRM. The members of the JWG share a common concern that the difficulty of sharing between satellite and terrestrial services could frustrate the business plans of all parties seeking to

use the 18 GHz band. A recommendation emerging from this process would be valuable to the industry and the Commission. We would very much appreciate your efforts in rejuvenating the JWG process.
