Low Power FM radio is a vere exciting issue for my community as well as myself. Our city is not represented by the stations available to us from 20 - 50 miles away. Some portions of our county cannot receive any radio. Trying to start up a regular FM station is not possible for most people. The costs are out of site. I highly encourage the FCC to pass this. We need this. The FCC must allow commercial as well as non-commercial stations. They both have a place. I feel allowing only non-commercial will doom this effort to failure.

The FCC must allow 100 meter HAAT. The terrain in moutainous areas such as mine would be severely limited with 60 meters as maximum.

I also encourage that 2nd and 3rd adjacent channel restrictions be removed. Advances in technology have eliminated most interference issues.

Rules should require owners to live within 50 miles of their station. This will keep the stations local, as it should be. That's one of the main points of this issue.

We need a local forum to discuss our issues. We need an avenue for rapid information. We need entertainment molded to our tastes.

Thank you for this opportunity for input. Our community will greatly benefit with LPFM.
