Likely answering points have been selected on the basis of past correspondence with the PSAP managers concerned, and should be verified during the implementation process. "MSP" indicates the district Minnesota State Patrol PSAP, "Local" indicates a preference for having calls answered at the local PSAP, and "Varies" indicates either splitting call routing by the specific location of the cell tower or by whether the local PSAP is ready to receive Enhanced Wireless 9-1-1 calls.
