On Wednesday, November 20, 2002, David Otten, Chairman & CEO of Celsat America, Inc. ("Celsat"), along with the undersigned of this firm, met with Donald Abelson, and Chris Murphy of the FCC's International Bureau. At the meeting, Celsat discussed the characteristics of satellite phones needed to ensure that the ancillary terrestrial component (ATC) satisfies the Commission's definition of "ancillary" set forth in the *Flexible Use NPRM*. Celsat also reiterated its view – as reflected in its comments in this proceeding – that the Commission's proposed satellite coverage requirement should be adopted.
