The participants discussed issues concerning the implementation of the Commission's bond requirement for new satellite applications, and the escrow alternative proposed by several of the participants. The participants also discussed the application of the bond requirement to non-U.S. satellites, and the Office of Management and Budget proposal on spectrum fees.
