Dear Madam Secretary:

On April 30, 2004, Verestar, Inc. (Debtor-in-Possession), Verestar Networks, Inc. (Debtor-in-Possession) (collectively, "Verestar") and SES AMERICOM, Inc. ("SES Americom") filed a series of applications seeking Commission consent to the assignment of certain licenses and authorizations from Verestar to SES Americom. *See* File Nos. SES-ASG-20040503-00672, SES-ASG-20040503-00673, ITC-ASG-20040429-00186, ITC-ASG-20040429-00187; ULS Submission No. 0001685559; and the Domestic Section 214 Authorization assignment application filed by hand with your office on that date. These applications appeared on *Public Notice* as acceptable for filing on May 26, 2004. *See Public Notice*, DA 04-1502; *see also Public Notice* DA 04-1686, released June 9, 2004.

On June 7, 2004, the above-referenced applications relating to the assignment of Verestar's Section 214 authorizations were withdrawn. *See* Letter from Jeffrey H. Olson to Marlene H. Dortch, Secretary, dated June 7, 2004. On June 23, 2004, the parties withdrew from the applications relating to the various microwave licenses all common carrier licenses. *See* Letter from Jeffrey H. Olson to Marlene H. Dortch, Secretary, dated June 23, 2004. Finally, on June 24, 2004, Verestar filed a series of applications requesting that all common carrier earth station licenses currently proposed for assignment to SES Americom be modified to non-common carrier status (attached hereto is a list of the call signs covered by those applications).

Verestar and SES Americom have determined that none of the services currently being provided by Verestar requires the use of an earth station designated as a common carrier facility, nor would such a facility be necessary for any such service to be maintained or continued by SES Americom after consummation of the transaction proposed in the above-referenced application. In brief, the conversion of these facilities to non-common carrier status will not result in the disruption or discontinuance of any service currently being provided by Verestar to any of its customers.

Therefore, consistent with the above-noted withdrawals of the other common carrier licenses and authorizations from the various assignment applications pending in IB Docket No. 04-174, SES Americom will not consummate the instant transaction until such time as the Commission has granted the requested modification of the subject earth station licenses to non-common carrier status. In sum, SES Americom does not seek to acquire any common carrier license or other authorization under any of the applications pending in IB Docket No. 04-174 that might be subject to the provisions of Section 310(b) of the Communications Act of 1934, as amended, 47 U.S.C. § 310(b).
